confinement of 89 girl children by the 9th Respondent and consequently direct the 1st Respondent to restore the children living in the custody of 9th Respondent to their respective parents.

As the orders passed by this court on previous occasions i.e. on 12.07.2016 and 19.07.2016, appear to have left some confusion in the minds of the authorities, what we intended to say, is that the blood samples must be subjected to D.N.A finger printing tests at Government Forensic Science Laboratory, Chennai. Now, it is being debated as to who should send the samples, namely, the District Collector or The Commissioner of Police, Trichy or the CBI.

We make it clear that any of them can send the samples to the Government Forensic Science Laboratory, Chennai for DNA finger printing test, so that, the report can be placed before us in time. However, we direct the Director of Government Forensic Science Laboratory, Chennai, to undertake the DNA finger printing test and make available the findings in a sealed cover on free of cost basis.
