ORDER: This petition coming on for orders upon perusing the petition and the affidavit filed in support thereof and upon hearing the arguments of M/S.M.SIDDHARTHAN, Advocate for the petitioner and of Mr.V.MURUGANANTHAM, Additional Government Pleader on behalf of the Respondents the court made the following order:-

Heard Mr.M.Siddharthan, learned counsel appearing for the petitioners and Mr.V.Muruganantham, learned Additional Government Pleader appearing for the respondents.

- 2. We have received the report submitted by the District Legal Service Authority and we are in the process of examining the same.
- 3. Today, when the matter was taken up for hearing, the learned Additional Government Pleader produced a typed set of papers, which shows the expenditure details and infrastructure arrangements made for the interview of the inmates and reasons for non-issuance of certificates to the inmates of the said home.
- 4. During the course of hearing, we were informed that the home is being granted by two women Police Constables and the Social Welfare Officer has not posted any staff in the home and all the

inmates, who are in the home, are taking care of their needs and necessities by themselves without any supervision or assistance.

- 5.We do not appreciate this state of affairs and we direct the Social Welfare Officer, Trichy, to forthwith post sufficient staff in the home and there atleast one staff should remain throughout the night and sufficient help should be organized so as to do cooking etc., permitting the inmates to assist the staff. All the staff must be female staff. A report, in due compliance of the above directions, shall be submitted by the District Social Welfare Officer, Trichy, on or before 28.06.2017 and the said Officer shall be present before this Court on 28.06.2017.
 - 6.List the matter on 28.06.2017.
