

**PRAYER:** Writ Petition filed praying that in the circumstances stated therein and in the affidavit filed therewith the High Court will be pleased to issue a writ of Mandamus directing the respondents herein to set the petitioners herein free forthwith from the control and custody of the respondents herein at Mose Ministries Home, Trichy and pass such further or other orders as this Hon'ble Court may deem fit and proper in the circumstances of this case and thus render justice.

**ORDER** : This petition coming on for orders upon perusing the petition and the affidavit filed in support thereof and upon hearing the arguments of M/S.M.SIDDHARTHAN, Advocate for the Petitioners and of MR.CHELLAPANDIAN, Additional Advocate General-III assisted MR.D.MURUGANANTHAM, Additional Government Pleader on behalf of the Respondents No.1 to 4 and of MR.N.NAGENDRAN, CBI Counsel for Respondent No.6, the Court made the following order:-

[Order of the Court was made by T.S.SIVAGNANAM, J.]

The learned counsel appearing for the parties have placed before this Court an order passed by the Hon'ble Supreme Court in S.L.P.No.1711 of 2018, dated 16.02.2018, which reads as follows:

"Mr.Colin Gonsavles, learned senior counsel appearing for the petitioners, submits that the petitioners-girls are capable of http://www.judis.nic.in looking after themselves and therefore, they may be released from the custody of the District Social Welfare Department. However, by way of abundant caution, we consider it appropriate to have the girls interviewed by an independent competent person and a report in that regard be placed before us.

We accordingly appoint Mr.Justice K.N.Basha, former Judge of Madras High Court and learned senior counsel, who is present in the Court today and has given his consent for the above purpose. Mr.Justice Basha may interview the girls at Madras High Court Mediation Centre at Madurai Bench, Madurai and accordingly, will submit a detailed report to this Court within a period of six weeks from today. We direct that the Madras High Court shall provide such accommodation and necessary facilities at Madurai for the aforesaid purpose.

The petitioners are directed to furnish a copy of the SLP paper-book to Mr.Justice Basha forthwith for his kind perusal.

We also appoint Mr.Karthikeyi Balan, learned Advocate, as Secretary to assist Mr.Justice Basha in the said task. Mr.Balan will maintain the necessary record.

It is made clear that all the expenses including travel and stay of the petitioners-girls shall be borne by the State of Tamil Nadu.

Needless to mention that the State of Tamil Nadu shall ensure proper safety, food, accommodation and other facilities are adequately provided to the petitioners-girls during their stay at Madurai.

List the matter along with the report after six weeks.

In the meantime, the petitioners are directed to take fresh steps to serve the unserved respondent".

2.In the light of the above order, we defer further proceedings in the matter to enable the Hon'ble Mr.Justice K.N.Basha, former Judge of Madras High Court, to carry out the exercise, as directed by the Hon'ble Supreme Court.

3.The learned Additional Advocate General appearing for the respondents 1 to 5, has produced before us, a copy of the complaint given by Ms.A.Mariyatheras and another, who had gone duty in the Home. A copy of the complaint shall be handed over to the Investigating Officer of Central Bureau of Investigation, who is present in Court and she shall enquire into the matter and submit a confidential report on the next hearing date.
